**Estimated Ancillary Service charge: \$0.005 per kWh and will be settled up to the actual charge each month.**

**Estimated PUC assessment charge:** \$0.00015 per kWh fee based on 1000 kWh use in a month at the average energy price of 9.3¢ and will be settled up to actual usage monthly. This fee is the charge assessed by the PUCT to recover the statutory fee for administering the Public Utility Regulatory Act. It is equal to 1/6th of 1% the charges on your bill, excluding sales tax.

**TDSP Delivery Charge: \$3.57 per month and 3.5¢ per kWh**

**TDSP charges:** This is what your local Utility charges for maintaining the transmission and distribution infrastructure and metering of your electricity. These costs are passed through without markup.

**Ancillary Service charges:** A service necessary to support the transmission of energy to Loads while maintaining reliable operation of the Transmission Service Provider's (TSP's) transmission system using Good Utility Practice.

**Price Formula:** ((kWh consumed \*(Hybrid Energy Charge+TDSP per kWh charge +Ancillary per kWh + PUC assessment charge) + TDSP Base Charge) divided by kWh consumed)

\*Prices are exclusive of state and local sales taxes, the Gross Receipts Reimbursement and TDSP underground charges where applicable

The wholesale price of electricity updates every 5 minutes, is published by ERCOT every 15 minutes, and includes the electricity charge plus any other per kWh system reliability charges - available at <http://www.ercot.com/mktinfo>, the Hybrid Power App, or call 1-844-949-2743
